**SUB: Selection Trial 1 & 2 in Rifle/Pistol events (Seniors) under Group “A” of Selection Criteria, at Dr. Karni Singh Shooting Ranges, New Delhi from 19<sup>th</sup> to 25<sup>th</sup> January, 2026**

Dear Sir/Madam,

1. In accordance with the Selection Criteria 2026, it has been decided to hold selection trials 1&2 under Group “A” in Rifle/Pistol events (Seniors) at Dr. Karni Singh Shooting Ranges, New Delhi as per the program attached as per Annexure “A”.
2. Scores will be entered in main log sheet for calculating the average and will be valid for selection of teams in International Competitions as per Selection Criteria 2026.
3. These trials will be organized and conducted by the NRAI. Athletes, who are eligible as per Selection Criteria 2026, will only be allowed to participate in these trials. The Selection Criteria is available on our website [www.thenrai.in](http://www.thenrai.in). Athletes are required to fill their entries in eligible category only.
4. The terms and conditions for selection trials are as under:
  - i. The tentative program is attached herewith. The time and **relays** will be notified on our website [www.thenrai.in](http://www.thenrai.in) after last date of filing entries (with Triple fee).
  - ii. Athletes will have to make their own arrangements for arms, boarding & lodging. Ammunition will be provided at Shooting Range against payment and on valid arms license.
  - iii. **Group A athletes are restricted from participating in any matches that are part of Group B trials in Olympic events. The 50m Rifle Prone event is designated exclusively for Group A Rifle athlete.**
  - iv. **Group A athletes** will be eligible to participate in the **CFP (Centre Fire Pistol)** and **STD (Standard Pistol)** events, which are **non-Olympic events**, conducted under **Group B trials**.
  - v. Entries of athletes with State approved shooter ID will be accepted.

The entries will be accepted through respective affiliated State Rifle Association/Units only. Entries will only be accepted through “NRAI’s ONLINE SYSTEM” and no paper entry will be accepted. **The athletes are required to visit our website [www.thenrai.org](http://www.thenrai.org) to file their entries along with online payment of entry fee. The online entries with normal fee will be accepted till 7.30 PM on 12<sup>th</sup> January, 2026. Late entries with triple entry fee will be accepted till 07.30 PM on 13<sup>th</sup> January, 2026.** The NRAI reserve the right to accept entries after this date as per clause 6.3 of NRAI Match book, subject to the availability of the **details/lanes**.

- vi. Please note that it takes 72 hours for your entry to reach on NRAI system, hence athletes should not contact or send email to NRAI immediately after filing their entries. It is informed that the State Rifle Associations have the right to reject your entry within 72 hours.
- vii. Athletes may send email to NRAI office for any assistance in case any issue related to filing of entry on email ID [indiashooting@gmail.com](mailto:indiashooting@gmail.com) .
- viii. **Details of entry fee are attached at Annexure “B”.** Entry fee will not be refunded except in the event of the match being cancelled.
- ix. Athletes may send email to NRAI office for any assistance on email ID [indiashooting@gmail.com](mailto:indiashooting@gmail.com)
- x. **ENTRIES SENT BY EMAIL ARE NOT ACCEPTABLE**
- xi. Athletes are required to print their competitor cards and Equipment Control Form and bring the same with them at the time of participation, failing which Rs. 236/- (Rs.200 + 18% GST) will be collected for each card/form, if supplied by NRAI.
- xii. Athletes can print their cards/forms after 13<sup>th</sup> January, 2026.
- xiii. If the athlete has given the Entry and wish to withdraw, he/she has to inform to NRAI as per Clause 3(d) (Rifle) and 3(e) (Pistol) of Selection Criteria 2026 through email only, giving reasons for the same.
- xiv. Athletes are required to enter the range 90 minutes before the reporting time of their **relays**.
- xv. **The list of eligible athletes for Group ‘A’ Selection Trials is attached and also available on our website.**
- xvi. The Group ‘A’ Selection Trials will be conducted for limited number of athletes as per the list given below:-

Air Rifle Men – 25  
Air Rifle Women – 25  
50M Rifle 3 Position Men – 20  
50M Rifle 3 Position Women – 20

Air Pistol Men – 25  
Air Pistol Women – 25  
25M Rapid Fire Pistol Men – 12  
25M Sport Pistol Women – 20

xvii. Once the ranking is announced – those athletes who are eligible to join Group “A” in one or more events would inform the NRAI [within 3 days of the announcement - if they are not desirous of being a part of Group “A”]. If any one or more athletes opt to join Group “B” then NRAI would fill the vacant slots with the next athlete. However, the NRAI would not permit athletes below the ranking of 20 athletes in the 25 M Pistol Women and 50M Rifle 3P events, 25 in the 10M events and for the Rapid-Fire Pistol event there will be no inclusion below the ranking of 12.

xviii. If an athlete belongs to Group “A” in one event but does not have the within mentioned ranking for the other Olympic event, then he/she may shoot the trial under Group “A” for the other event- subject to achieving MQS in that event.

xix. A TOP athlete, who desires to shoot a selection trial for examining/ experimenting /testing of new /changed technique / equipment - under competition conditions, may shoot as a ZERO ATHLETE and such scores shot for experimental purpose would not be considered in the calculation of MAM. Provided that the athlete requests in writing, prior to the competition, stating that s/he wishes to shoot as a Zero Athlete. This provision will be available only to the top 8 ranking athletes of that event and ONLY 24 IF the athlete has sent an email application **BEFORE 5 PM ON PREVIOUS DAY OF THE TRIAL. APPLICATION RECEIVED AFTER THIS TIME WILL NOT BE CONSIDERED AND SCORE SHALL BE CONSIDERED FOR MAM, IF THE ATHLETES OPTS FOR SHOOTING THE TRIAL.**
