Dear Sir/Madam,

The National Rifle Association of India (NRAI), in association with the International Shooting Sport Federation (ISSF) and in collaboration with Sports Authority of India (SAI) & Olympic Gold Quest (OGQ), presents the ISSF Shotgun Referee Course, a structured professional development programme designed to elevate Indian Shotgun Referees in line with evolving international officiating standards under NRAI Education Program.

The course will be held from **3rd to 7th August 2026** at **New Delhi, India under the aegis of the National Rifle Association of India**. The instructors nominated by ISSF to conduct this course are Mr. Nooruddin Alyasi (BRN), and Mr. Amar Jang Singh (IND)


The program will be **free of cost** for the selected participants. Participants will have to make their own arrangements for boarding/lodging and transport. The lunch and other refreshments during the days of the Course will be provided to the participants free of cost

15 participants in total shall be selected as mentioned in selection guidelines.

Applicants, who fulfill the following conditions, shall only be considered for the Course:

1. Candidates above the age of 25 years can only attend the Course.
2. Minimum educational qualification – Senior Secondary(12th) and Mandatory to have knowledge of English -Verbal and Written.
3. The selection of participants for this course will be made based on the information provided by the applicants in the online application form



4. The criteria for selection include the following parameters:
 - **First preference** will be given to officials currently working with the NRAI and do not hold an ISSF License.
 - **Second preference** will be given to applicants who have successfully completed the NRAI Shotgun Referee Course.
 - **Third preference** will be given to applicants who previously held ISSF Judges License but failed to renew it.
 - Applicants willing to attend this course must complete 60 days of mandatory internships as an official in NRAI-sanctioned tournaments and are required to fill out the undertaking as well.
5. The NRAI holds the right to approve/reject the application of any participant for the course.
6. Those who are desirous of attending the above course should submit the online application by **July 8th 2026 before 5:00 PM.**
