RECOMMENDATIONS OF THE TECHNICAL COMMITTEE ON 16 NOVEMBER 2021

(Subject to approval by the Governing Body of NRAI)

1. To introduce new Matches on the Program of NSCC:

The following events are introduced on the program of NSCC

Standard Pistol Junior Women Free Pistol Women Free Pistol Junior Women

For participation in these events, shooters who are eligible to participate in any one event at the National Championship (i.e. if they are eligible to participate in the APW or SPW event) would be permitted to participate in these events. However to be declared as "Renowned Shots" they would be required to achieve the MQS as stated in 17.6. These events will not be conducted during AIGVMSC/ZONAL Championships.

Rapid Fire Pistol Mix Team Event: The ISSF has not introduced it as an individual ISSF match for women. It was recommended that Rapid Fire Pistol match for Women be conducted solely during the selection trials – for the purpose of selecting the mixed team as indicated within. Shooters who achieve the following score during Duelling Course of Sports Pistol in NSCC will be allowed to participate during selection trials:

Sports Pistol (W) Rapid fire stage (duelling):

Women - 285 Women Jr. – 280

- 2. A new Category of shooters aged between 45-60 years be introduced "Masters" and to convert the old veteran category also to "Senior Masters". Hence Senior Master will be a category for shooters above the age of 60 and Master category would be for shooters between the ages of 45-60. Shooters above the age of 60 would be permitted to participate in Masters Category. These shooters are required to achieve MQS, as per Table under 17.6 of NRAI Match Book, to be notified as renowned shooter.
- 3. In view of the large number of shooters participating in Rifle and Pistol events during AIGVMSC and number of days involved for the conduct of this event, if both the events are conducted at same venue, it was recommended that the Rifle and Pistol events be conducted at two different venues. The ranges, which can handle large number of shooters and with easy access, should be allotted the conduct of these events.
- 4. It was further recommended to permit shooters to participate in any or all Rifle / Pistol / Shot Gun / Big Bore Rifle events at the Zonal / AIGVMSC and the Nationals. However NO concession would be made for detail allotment and overlapping of events. The NRAI would not make any concessions for shooters who had overlapping matches due to participation in more than one stream / section of shooting. Also shooters who are members of the NSQ or participate in any Open Selection Trial would not be permitted to participate in more than one category in the selection trials or would not be members of the NQS in more than one stream / section.

- 6. The House recommended revision in MQS under Rule 1.4 and 17.6 of NRAI Match Book. The revised MQS under rule 17.6 of NRAI Match Book are attached herewith at Annexure A. These will be applicable from 65 NSCC and shooters are required to achieve revised MQS during 64 NSCC to be able to participate in 65 NSCC. The revised MQS under Rule 1.4 will be published shortly.
- 7. The MQS for participation in selection trials in 2023 were proposed and recommended that these may be implemented for the year 2022-23. The proposed MQS are attached herewith at Annexure B.
- 8. It was recommended that Aadhar Card number should be mandatory for shooters applying for Shooter ID. The applicant must upload copy of Aadhar Card with other documents. The existing ID Card holders must attach copy of Aadhar Card and enter Aadhar Card number at the time of renewing the same.
- 9. It was recommended that Clause 1.8 be inserted as under:

For the purpose of a shooting year, stated under these rules: Beginning from the first day of NSCC to the first day of next NSCC - will be one shooting calendar year.
