It has been decided to conduct two Selection Trials 3 & 4 in Shotgun events at Dr. Karni Singh Shooting Ranges, New Delhi from 21st to 30th May 2022 as per the schedule given below:

Please note the following points:

1. All Shooters, who were eligible to shoot Shotgun Trial 1 & 2, will be allowed to participate in Selection Trials 3 & 4.
2. The selection trials will start tentatively at 8 AM.
3. There will be only one PET for both trials. Timings of PET and Finals will be announced at the Range
4. These trials will be organized and conducted by the NRAI. The matches will be conducted in accordance with the new format introduced by the ISSF.
5. The list of squads will be put up on the main notice board before the start of the matches

6. **THE ENTRIES WILL ONLY BE ACCEPTED “NRAI’s ONLINE SYTEM” and no paper entry will be accepted. The shooters are required to visit our website www.thenrai.org to file their entries along with online payment of entry fee. The online entries with normal fee will be accepted till 9.30 PM on 10th May 2022. Late entries with triple entry fee will be accepted till 9.30 PM on 13th May 2022. Entry Fee for both selection trials is Rs. 9,900/-**
7. The scores of these selection trials will be considered for selection of team for international competitions as per Selection Criteria
8. The ammunition will be available at the ranges against payment on valid arms license
9. The Selection Committee has the right to select the final team for any Competition.
10. Shooters who have been fully vaccinated must carry final vaccination certificate. In absence of this, shooters must undergo a COVID-19 test prior to entering the range for first trial and submit a negative report from a Govt. certified lab to NRAI. This report should not be older than 72 hours from the date of first trial. It also applies to the persons accompanying the shooter.
11. Entry Fee is non-refundable except when the event is cancelled by the NRAI
