Please note the following points:

1. The selection trials will start tentatively at 10 AM.
2. These trials will be organized and conducted by the NRAI. The shooters as per list attached – Annexure “A” are only permitted to participate in these trials
3. **THE ENTRIES WILL ONLY BE ACCEPTED “NRAI’s ONLINE SYTEM”** and no paper entry will be accepted. The shooters are required to visit our website [www.thenrai.org](http://www.thenrai.org) to file their entries along with online payment of entry fee. The online entries with normal fee will be accepted **till 9.30 PM on 24<sup>th</sup> March 2022**. Late entries with triple entry fee will be accepted till 9.30 PM on 27<sup>th</sup> March 2022. Entry Fee for both selection trials is Rs. 9,900/-
4. The scores of these selection trials will be considered for selection of team for ISSF Junior World Cup, Suhl, Germany and for further international competitions
5. The ammunition will be available at the ranges against payment on valid arms license
6. The Selection Committee has the right to select the final team for these Competitions.

7. Shooters who have been fully vaccinated must carry final vaccination certificate. In absence of this, shooters must undergo a COVID-19 test prior to entering the range for first trial and submit a negative report from a Govt. certified lab to NRAI. This report should not be older than 72 hours from the date of first trial. It also applies to the persons accompanying the junior shooter.
8. Entry Fee is non-refundable except when the event is cancelled by the NRAI
