SUB: Selection Trial 5 & 6 in PISTOL events under Stage 3 of Selection Criteria, at Dr. Karni Singh Shooting Ranges, New Delhi for (Men, Women, Juniors & Youth Men & Women) from 17th to 30th August 2022.

Dear Sir/Madam,

1. In accordance with the Selection Criteria 2022, it has been decided to hold selection trials 5 & 6 under Stage 3 in Senior, Junior & Youth Men and Women Pistol events at Dr. Karni Singh Shooting Ranges, New Delhi as per the program attached as per Annexure “A”.

- i. THE MATCHES WILL START AT 8:00 A.M
- ii. DETAILS WILL BE PUT UP ON THE WEBSITE/MAIN NOTICE BOARD BEFORE THE START OF THE MATCHES.
- iii. PROGRAM OF FINALS WILL BE ANNOUNCED SEPERATELY.
- iv. PROGRAM IS SUBJECT TO CHANGE AND CHANGES, IF ANY, WILL BE NOTIFIED AT THE VENUE.

THE MATCHES WILL BE CONDUCTED AS PER NEW ISSF FORMATS/RULES OF ISSF.

2. Scores will be entered in main log sheet for calculating the average and will be valid for selection in subsequent international competition as per Selection Criteria.

3. These trials will be organized and conducted by the NRAI. Shooters, who have achieved the scores as per annexure “A” of Selection Criteria 2022, during the following competitions, will be allowed to participate in these trials. The Selection Criteria is available on our website www.thenrai.in

- i. 64th NSCC, New Delhi 2021
- ii. 20th KSSMSC, Bhopal, 2022
- iii. Those shooters who were permitted to shoot the ST 1 & 2 in March 2022 based on their previous average would be permitted to shoot the Selection Trials.
- iv. Rajiv Gandhi Khel Ratna Awardee / Arjuna Awardee are exempted from MQS in the category in which they have received award.

4. The terms and conditions for selection trials are as under:

- i. The tentative program is attached herewith. The time and details will be notified on our website www.thenrai.in after last date of filing entries (with Triple fee).

- ii. Shooters will have to make their own arrangements for arms, boarding & lodging. Ammunition will be provided at Shooting Range against payment and on valid arms license.
- iii. A shooter, who has achieved the following scores in the Rapid-Fire Stage (dueling) of the Sport Pistol Event in 64 NSCC and is also eligible to participate in the Open Selection Trials; will be eligible to participate in the selection trials for the Rapid Fire Pistol Women event. These trials will be conducted solely for the selection of the team for the RFP Mixed event at international competitions and for no other purpose.
 - a. Rapid fire stage (Dueling)
 - b. Women 285
 - c. Junior Women 280
- iv. In 50M Pistol and 25M Standard Pistol Junior Women events, shooters who are eligible to participate in any one event during the selection trials (i.e., if they are eligible to participate in the APW or SPW event) they would be permitted to participate in these events.
- v. **THE ENTRIES WILL ONLY BE ACCEPTED IN “NRAI’s ONLINE SYTEM” and no paper entry will be accepted. Shooters are required to visit our website www.thenrai.org to file their entries online. The online entries with normal fee will be accepted till 11.30 PM on 4th August 2022. Late entries with triple entry fee will be accepted online till 11.30 PM on 6th August 2022.**
- vi. **Details of entry fee are attached at annexure “B”.** Entry fee will not be refunded except in the event of the match being cancelled.
- vii. Shooters may contact Mr. Anjan Singh in NRAI office on phone number +91-9555046539 during working hours for any assistance. Shooters may also send email on email ID indiashooting@gmail.com
- viii. Shooters, who are below 21 years and 19 years of age as on date of start of trials will be considered under the category of JUNIORS and YOUTH respectively for these trials. Their selection for International Competitions will be subject to age criteria laid down by ISSF.
- ix. **A Transit shooter, who is qualified to shoot Junior/Youth Trials by virtue of having shot the requisite MQS in the 64th NSCC would be eligible to shoot the Senior/Junior STs for the year 2022.**
- x. **ENTRIES SENT BY EMAIL ARE NOT ACCEPTABLE.**
- xi. **All shooters must attach a photocopy of their valid passport while filing online entry, if not done earlier. Please ignore, in case the copy of the passport, which is valid as on date of filing the entry, has already been uploaded on our system.**

- xii. Shooters are required to print their competitor cards and Equipment Control Form and bring the same with them at the time of participation, failing which Rs. 200/- will be collected for each card/form, if supplied by NRAI.
- xiii. Shooters can print their cards/forms after 7th August 2022.
- xiv. The Finals will be conducted as per ISSF Rules in all Olympic events (Senior, Junior and youth events).
- xv. Shooters who desire to change their match dates, due to their exams, must write with all supporting documents to NRAI before 6th August 2022, after which no request for any adjustment shall be entertained. Please note that request for change of date to participate, after completion of the match, shall not be entertained. The relaxation form is attached along with circular.
- xvi. Requests will be answered within 3 days (72 hours) i.e., 9th August 2022 after the last date of receipt of request, as per the terms and conditions mentioned in the relaxation form.
- xvii. No response will be given to shooters who send their request without supporting documents or incomplete information as mentioned in the Relaxation Form.
- xviii. Any athlete who provides false information for his/her lane adjustment will be subject to disciplinary action.
- xix. The NRAI has the right to accept or reject any request for relay adjustment.
- xx. **The teams for participation in ISSF World Championship in Non-Olympic events will not be funded by either National Rifle Association of India or Sports Authority of India. The Governing Body in its meeting held on 18th June 2022 has decided that the NRAI would bear the cost of Entry Fee and Kit for the shooters who are willing to participate in ISSF World Championship 2022 at their own cost. However, only 3 shooters as per the ranking will be allowed to participate at their own cost.**
- xxi. If the shooter has given the Entry and wish to withdraw, he/she has to inform to NRAI 48 hours before the commencement of his/her event, giving reasons for the same.
- xxii. **COVID PROTOCOLS:**
 - a) Due to COVID – 19 conditions, shooters are requested to strictly follow SOPs as laid down by Govt. of India/Delhi State Govt.
 - b) All shooters/coaches must undergo a COVID-19 test prior to entering the range for training and submit negative report from a Govt. certified lab to NRAI. This report should not be older than 48 hours from the date of your first entry at the range. In case a person has been administered both the jabs, copy of the Final certificate issued by the concern authorities should be produced at the time of entry at the range.

- c) **Only one person will be allowed to accompany the shooter subject to production of valid negative COVID – 19 report/Final Certificate.**
- d) **Shooters are required to enter the range 90 minutes before the reporting time of their detail.**
