Ich erkläre mein Einverständnis, dass jeder Streit, der zwischen mir und der ISSF entsteht und nicht freundschaftlich erledigt werden kann, und der nach Ausschöpfung der Verfahrensvorschriften, die in den ISSF Regeln vorgesehen sind, offen bleibt, endgültig durch ein Schiedsgericht entschieden werden soll, welches in Übereinstimmung mit den Statuten und Regeln des Schiedsgerichts für Sport in Lausanne (CAS) zusammengestellt wird unter Ausschluss der Anrufung ordentlicher Gerichte. Die Parteien verpflichten sich, die erwähnten Statuten und Regeln zu beachten und die Entscheidung im guten Glauben anzunehmen und ihre Durchsetzung in keiner Weise zu behindern.

1.	Confirmando haber tomado conocimiento de la reglamentación y de las sanciones en vigor en las competiciones oficiales de la ISSF respecto a la lucha contra el dopaje. Estoy de acuerdo en someterme a las pruebas de control antidopaje, aceptar sus resultados y respetar el reglamento tal como esté en vigor en cualquier momento dado.
2.	Estoy de acuerdo en que todo litigio entre mi persona y la ISSF que no pueda resolverse de forma amistosa, aún después de agotar los procedimientos previstos por la ISSF, se decida definitivamente por un tribunal constituido de acuerdo con los Estatutos y el Reglamento del Tribunal de Arbitraje del Deporte, Lausana sin posibilidad de recurso a los tribunales ordinarios. Las partes en litigio se comprometen a respetar tales Estatutos y Reglamento, aceptar de buena fe la sentencia pronunciada y no dificultar su ejecución.

# ISSF Athlete Declaration

1. I hereby confirm that I am aware of the rules and regulations of the ISSF and penalties in force for the official competitions of ISSF, including the rules relating to the fight against doping. I agree to submit to the doping control tests, to accept the results of such tests and to abide by the respective regulations in their prevailing form at any given time.
2. I agree that any dispute arising between myself and ISSF which cannot be settled amicably and which remains once the procedures provided for in the ISSF Regulations have been exhausted, shall be settled finally by a tribunal composed in accordance with the Code of the Sports-related Arbitration (CAS Code) and before the Court of Arbitration for Sport, Lausanne, to the exclusion of any recourse to ordinary courts. The parties undertake to comply with the said CAS Code and to accept in good faith the award rendered and in no way hinder its execution.
3. I am aware that ISSF holds the International broadcasting rights of all the events I am taking part in, therefore I am aware that, by taking part in such events, my personal data, including image, likeness, name, voice and my declarations, in addition to my sports activities, will become part of the International TV production, therefore irrevocably part of the broadcasting rights of ISSF, who retains any right to commercialize the events, or parts of it, to any third party ISSF appoints as licensee, without any limitation of time, runs, language and space.
4. The TV productions realized by ISSF and the related audiovisual material are, and will be, property of ISSF, holding full and discretionary right to use, exploit and commercialize such productions directly or through third parties ISSF grants such right, including, but not limited to: TV rights holders, sponsors of ISSF and/or National Federations, partnering social media accounts.
5. The audiovisual material ISSF holds the rights of, may be exploited for commercial and non-commercial purposes on several media platforms, including, but not limited to TV channels, social media, websites, editorials, web platforms, public relations.
6. For the sake of clarity, the International TV productions of ISSF cover all the activities and events during and in connection with the competition, including, but not limited to, at the competition venue or site, such as:
  - shooting range (competition and training)
  - ceremonies
  - warm up area
  - athletes' lounge
  - mixed zone
  - any other location or event directly related to the event (e.g. side-events in town of competition, etc)
7. I agree that, for the purposes of promoting shooting sport worldwide, immediately after each Final of the ISSF competition, I will make myself available for interviews with TV rights holders and ISSF TV production team in the TV Mixed Zone of the respective competition, upon their request, to the extent, quantity and scope that is reasonable and that can be expected of an

international athlete.

8. I acknowledge that the ISSF may use my photo for the use on accreditation cards and/or to post it on the ISSF website as part of my athlete profile.
9.
