Sub: NRAI Judges Course (Rifle & Pistol)

Dear Sir/Madam,

It gives me great pleasure to share with you that the NRAI has a new Judges Course to upskill and update the knowledge of match officials. It will be NRAI's own Judges Education Program which includes course design and material to address the developments in shooting sport and to equip our match officials with the correct tools.

The program will be from 7^{th} to 10^{th} May 2023 at Dr. Karni Singh Shooting Ranges, New Delhi under the aegis of the National Rifle Association of India.

As a commitment by NRAI towards promoting, the sport of shooting in the country, with the collaboration with OGQ, the program will be **free of any course fee** for the selected participants. Lunch and other refreshments during the days of the Course will be provided to the participants. However, they will have to make their own arrangements for boarding/lodging and transport.

Eight participants in each discipline shall be selected, as mentioned in the selection guidelines. Apart from this, two participants in each discipline shall be selected by NRAI from upcoming states in shooting sport.

Only applicants, who fulfill the following conditions, shall be considered for the Course:

- 1. Candidates above the age of 21 years can only attend the Course.
- 2. Minimum educational qualification Graduation and must have knowledge of English.



- 3. The selection of participants for this course will be made based on the information provided by the applicants in the online application form.
- 4. The criteria for selection include the following parameters:
 - ✓ Previous National, State and Regional Match official work experience & certification (Duly signed and stamped declaration Form) /Letter issued from Association/ Unit
 - ✓ Performance of applicant as a shooter (only performance of NSCC/International Competition will be considered)
 - ✓ Applicants, who have attended the NRAI and ISSF National Coaches Course will not be given preference.
- 5. The NRAI holds the right to approve/reject the application of any participant in the course.
- 6. Those who are desirous of attending the above course should submit the online application by Thursday, 20th April 2023.
