Sub: STAGING OF 64th NATIONAL SHOOTING CHAMPIONSHIP COMPETITIONS (NSCC) IN SHOTGUN EVENTS AT NEW MOTI BAGH GUN CLUB, VILLAGE MAIN, PATIALA, PUNJAB FROM 22nd NOVEMBER TO 14th DECEMBER 2021

Dear Sir/ Madam,

The 64th National Shooting Championship Competitions (NSCC) 2021 in Shotgun events will be held at New Moti Bagh Gun Club, Village Main, Patiala, Punjab from 22nd November to 14th December 2021 as per details given in program attached at Annexure "A". This National Championship will be organized and conducted by the National Rifle Association of India, as per rules and regulations under NRAI Match Book 2018 (amended). The NRAI Match Book 2018 (amended) is available on our website www.thenrai.in

Those competitors, who want to participate in this competition, are requested to go through the following instructions carefully for their own convenience and to ensure smooth and successful conduct of the above competitions.

1. PARTICIPATION, MATCHES, ENTRY FORM & FEE

- a. Participation is open to competitors from State Rifle Associations/ Units affiliated to NRAI. In case where no State Rifle Association exists, competitors belonging to clubs directly affiliated to NRAI will be allowed to participate. NRAI members must take part through State Rifle Associations/ Units of their native place otherwise their entry will not be accepted. However, if there is no such Association / Club functioning in their State, they can take part as members of NRAI provided they have paid all their dues towards NRAI. State Rifle Associations/Units will allow the members of NRAI to participate in the competitions organized by NRAI without becoming a member of that State/Club to which he/she belongs subject to the member undertaking to follow all the rules and regulations applicable to the shooters of that State. The State Rifle Associations/units may also charge an additional fee equal to entry fee of the competition but not more than Rs. 5000/- for forwarding the entries of Life/Annual Members of NRAI. This is applicable when these shooters are not members of State/Unit or any District/club to which Members of NRAI wish to represent. The Members of NRAI must have achieved MQS as defined for each competition under NRAI Match Book
- b. Shooters, who are below 21 years as on 22nd November 2021, will be considered under the category of JUNIORS for the Championship. **SHOOTERS BELOW THE AGE OF 12 YEARS ARE NOT ALLOWED TO PARTICIPATE IN THIS CHAMPIONSHIP.**

- c. Those shooters, who have not received/ applied for their Shooter ID number, must immediately visit our website www.thenrai.in to check status/apply for their Shooter ID number.
- d. **SHOOTERS, WHO ARE ALREADY IN POSSESSION OF SHOOTER ID, ARE NOT REQUIRED TO APPLY FOR FRESH ID REGISTRATION AND ENTRIES WILL BE ACCEPTED ON EXISTING REGISTRATION.**
- e. List of the individual events is attached herewith as Annexure "B". The entries will be accepted through respective affiliated State Rifle Association/Units only. Entries will only be accepted through "NRAI's ONLINE SYSTEM" and no paper entry will be accepted. The Shooters are required to visit our website www.thenrai.org to file their entries along with online payment of entry fee. The online entries with normal fee will be accepted till **11.30 PM on 7th November 2021**. Late entries with triple entry fee will be accepted till 11.30 PM on 10th November 2021.
- f. Shooters may contact Mr. Anjan Singh in NRAI office on phone number **011-8700094163** during the working hours for any assistance. Shooters may also send email on email ID indiashooting@gmail.com
- g. Juniors can also participate in senior category with the payment of additional entry fee as per rules.
- h. Shooters, who achieve MQS as per Rule 17.6 of NRAI Match Book 2018 (amended) (as per Annexure "C" attached) will be notified as "Renowned Shooter".
- i. Shooters qualified, as per NRAI Match Book 2018 (amended) Rule 17.6 (as per Annexure "C" attached) are eligible to participate in this NSCC. Shooters furnishing incorrect information shall be debarred from taking part in any championship for two years (Rule 17.10 of NRAI Match Book).
- j. Entry fee will not be refunded except in the event of the match being cancelled. The entry fee should be paid "online" only and no cash/draft will be accepted. Shooters will be permitted to shoot only in the squads allotted to them. No requests regarding change of squads will be entertained.

2. TEAM REPRESENTATION

Team events will be conducted in accordance with Rule 18 of NRAI Match Book 2018 (amended). Only one Team from each State/ Unit will be allowed in each event irrespective of the number of participants in National Championship Category. Final entry of three members of the team must be submitted latest by 17.00 hrs. on the previous day of the start of that particular match.

3. MIXED EVENTS

The Mixed Trap and Skeet events will be conducted as per ISSF Rules. All affiliated units which wish to enter must file their entries before **2 PM on 7th November 2021 at NRAI Camp office at New Moti Bagh Club, Patiala**. Only one team, consisting of one male and one female of the same state/unit, can be fielded. Entry fee is Rs. 6000/- per team. The Following are rules for participation in Mixed Event matches:

1. All matches will be shot as per ISSF Rules
2. Each team will consist of two shooters.
3. Each team mandatorily will consist of one male and one female shooter.
4. Each Affiliated State/Unit can field only one team.
5. No shooter can be a member of more than one team in the same event.
6. Shooters can represent their State/Unit only and teams cannot be formed having shooters from two different State/units.
7. Shooters participating in Mixed Events must have MQS as prescribed in Rule 17.6 of NRAI Match Book.
8. There will not be any individual event/medal.
9. Team medals will be awarded as per Rule 10.2 of NRAI Match Book 2018.
10. It is strongly advised that the athletes from each State/Unit wear the same type of color of clothing.

4. PROTESTS AND APPEALS

The Protests and appeals will be dealt as per ISSF & NRAI Match Book 2018 (amended). The Protest fee is Rs. 200/- and in case of appeal to Jury of Appeal, the protest fee is Rs. 500/-.

5. AMMUNITION

- a. The ammunition will be issued to the Team Manager only against cash payment on valid Arms Licenses of Associations/ Clubs/ Individuals or proper special permit issued by the Licensing Authorities. In case of inadequate authorization, special permits for the required quantity are obtained from the Local Licensing Authorities. Unused rounds and empties of used rounds are to be returned to NRAI without any exception.
- b. In extra ordinary circumstances, the Organizing Secretary may grant permission for use of a common weapon. The names of shooters likely to use common weapon should be advised together with the weapon number to the Organizing Secretary in advance to enable him to work out details for conduct of relevant matches.

6. ACCOMMODATION

Participants are requested to kindly make their own arrangements for accommodation. A wide range of hotels for all budgets are available at Patiala.

7. GENERAL

- a. All participants are requested to go through the above instructions carefully and ensure strict compliance.
- b. All participants are expected to abide by the rules and regulations for the competition. Discipline on and off the field is very essential.
- c. In case of non-participation by the competitors after submission of their entries will not be allowed any refund of the Entry Fee.
- d. Shooting kit (clothing & Equipment) of the competitors during the competition will be strictly according to ISSF Rules.
- e. Shooting practice in hotels is strictly prohibited.
- f. The Organizers will have the right to close any match or event in case of any emergency or otherwise without assigning any reason for such an action on their part.
- g. The Organizing Committee reserves the right to amend the rules at any time at its sole discretion for events/circumstances beyond its control. Any decision made by the Organizing Committee in any such matter will be final. All participants are expected to abide by the rules and regulations for the competitions. Discipline on and off the field is very essential. Shooting practice in hotels is strictly prohibited.
- h. **Scores of this NSCC will be considered for selection of National Squad and international teams under the Selection Policy which will be published before the start of the NSCC.**
- i. **The Selection of National Squad and international teams will be done in accordance with the Selection Policy.**
- j. **The scores as per score board/computerized score sheet, printed from the centralized scoring system installed at the range and shall only be valid. The Referees are required to make corrections, if any, on spot, during the round well before printing the score sheet. No correction is permissible once the printout has been taken."**
- k. **COVID PROTOCOLS:**
 - i. **Due to COVID – 19 conditions, shooters are requested to strictly follow SOPs as laid down by Govt. of India/Punjab Govt.**
 - ii. **All shooters/coaches must undergo a COVID-19 test prior to entering the range for training and submit a negative report from a Govt. certified lab to NRAI. This report should not be older than 48 hours from the date of your first entry at the range.**
 - iii. **No request for any adjustment shall be entertained. The time and details will be notified on the website of NRAI. Shooters are required to enter the range 90 minutes before the reporting time at range so that they can report on time for their detail.**
 - iv. **Only one person will be allowed to accompany the shooter subject to production of valid negative COVID – 19 reports.**
