Sub: Maintenance of attendance and discipline among National campers

Please refer to the approved minutes of ACTC meeting issued in sports disciplines for which the National camp is being held in your centre/institution. Your attention is invited to the following paragraph mentioned in the ACTC minutes with regard to maintenance of discipline in the national coaching camps:

"No unauthorized absence from national camps would be allowed. No one would be allowed entry after start of the camp. Based on the recommendations of an officer authorized by concerned NSF leave of absence would be allowed by prior permission of the Head of the institute where the coaching camp is organized. Unauthorized absence during dope testing call would be presumed deliberate leading to consequent action by the concerned NSF."

To comply with the above, you may evolve and put in place a robust mechanism to ensure attendance and discipline among the national campers including coaches and support staff training in the centre/institute. The Head of the Institutes should ensure that the national campers abide by the rules and regulations of the centre/institute. No national camper should be allowed to leave the campus without the consent of the Head of the Institute. Leaves of more than 1 day availed by the national campers should be informed to the Office of the Regional Director (TEAMS) and concerned Project Officer. These instructions should be adhered to strictly.
