Election for the post of President, The National Rifle Association of India (NRAI) under Clause 8 and 11 of Rules and Regulations of NRAI, for the remaining term of 2021-25

## **REVISED MEMORANDUM OF PROCEDURES & GUIDELINES (MOPG)**

### **1. Short Title & Definitions**

- (1) The MOPG shall govern the conduct of Election for the post of President of THE NATIONAL RIFLE ASSOCIATION OF INDIA (NRAI) for the remaining term of 2021-25.
- (2) In the MOPG, unless the context otherwise requires,
  - (a) 'clause' and 'sub-clause' of the MOPG mean the clause and sub-clause of these Bye-laws;
  - (b) 'Form' means the Form appended to the MOPG;
  - (c) 'Post' includes the office of President of Governing Body of NRAI.
  - (d) 'Rules' mean the Rules and Regulations of THE NATIONAL RIFLE ASSOCIATION OF INDIA.

### **2. Election to the post of President**

The election is to fill up the vacancy for the post of President NRAI for the remaining term of Governing Body, which has occurred due to resignation by Mr. Raninder Singh from the post of President.

### **3. Manner of Election:**

- (1) The Elections shall be conducted to fill the casual vacancy in accordance with Clause 8 and Clause 11 of Constitution and Rules and Regulations of NRAI (as amended on 28<sup>th</sup> October 2022).
- (2) Election for the post of President NRAI shall be for the remaining period of the term 2021-25 under the direct supervision and control of Returning Officer.
- (3) Election shall be held during the General Body Meeting in accordance with the procedure prescribed hereinafter.

#### 4. Electoral College:

- (1) The members of the General Body of NRAI, as per **Form 1 dated 3<sup>rd</sup> September 2021**, which elected the office bearers and members of the Governing Body on 18<sup>th</sup> September 2021 for the current term of the Governing Body (2021-25) under Rules and Regulations of NRAI, shall have one vote each at the elections for the post of President NRAI.
- (2) No other person(s) including ex-officio members, Life and Annual members shall have the voting power to cast vote in this election.
- (3) The Secretary General shall also furnish a duly authenticated copy of the list of members mentioned in Form 1 as stated under sub-clause (1) above to the Returning Officer.

#### 5. Returning Officer:

- (1) The Governing Body of NRAI, as per Email circulation dated 24<sup>th</sup> May 2023 has approved the proposal of the Secretary General NRAI to appoint the Returning Officer for the conduct of Election for the post of President NRAI in accordance with the provisions of the MOPG to be prepared & issued by the Returning Officer.
- (2) MOPG, once issued by the Returning Officer, shall be placed on the website of the NRAI, and also be circulated by Registered post/email to all members of the General Body of NRAI having voting right as per **Form 1** along with the agenda for the meeting of the General Body of NRAI.
- (3) The Secretary General NRAI vide his letter no. TRG/ELECTION/2023 dated 26<sup>th</sup> May 2023 has approached the undersigned for being as the Returning Officer (RO) to oversee the preparation of, institution, & execution of this election byelaws during the entire electoral process culminating in the conduct of the election and declaration of the result as fixed for **21<sup>st</sup> September 2024**.
- (4) The Returning Officer shall have the power to invite observer/s from the Union Ministry of Youth Affairs & Sports, to observe the conduct of the meeting of the General Body of the NRAI on **21<sup>st</sup> September 2024**.
- (5) The office of the Returning Officer shall be located at Constitution Club, Rafi Marg, New Delhi.



## 6. Nomination of Candidates:

- (1) The nomination of a candidate for election as President shall be made in **Form 2**.
- (2) All persons, who are members of the General Body of NRAI for the term 2021-25, are eligible to contest the election of President NRAI. List of members of the General Body of NRAI is as per **Form 1**.
- (3) The nomination of a candidate for election shall be proposed by one of the members of the General Body, whose name is included in **Form 1** and subscribed by 1 (one) such member of the General Body as seconder.
- (4) Each candidate can be nominated by not more than 2 (two) nomination papers.
- (5) Each Nomination Paper shall be delivered personally to the Returning Officer at Constitution Club, Rafi Marg, New Delhi – 110001 in person by the candidate himself/herself or through his/her authorized representative **on 31<sup>st</sup> August and 1<sup>st</sup> September 2024 between 11.00 am to 1.00 pm on each day**.
- (6) No person shall be eligible to nominate more than-one candidate, either as proposer or seconder; and, if he / she so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative.
- (7) No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been delivered to Returning Officer.
- (8) As soon as may be possible **after 11 AM on 2<sup>nd</sup> September 2024**, the Returning Officer shall prepare a list of all nominations received by him, in **Form 3**; and publish the same in NRAI Office and website of NRAI.
- (9) Election by Gov. servants: A Govt. servant may be allowed to hold elective office for two terms or for a period of 5 years, whichever is earlier, for which prior sanction would be required when a Govt. servant contests an election as per existing rules.

## 7. Scrutiny of Nominations:

- (1) On **3<sup>rd</sup> September 2024 at 11.00 am**, the Returning Officer in his Office at Constitution Club, Rafi Marg, New Delhi – 110001 shall scrutinize each nomination paper, one by one, received by him, and determine its validity or otherwise.
- (2) At the scrutiny of nominations, each candidate or his/her authorized representative shall have the right to be present and raise any objection in relation to nomination of a candidate for the post for which he/she has filed his/her nomination.



- (3) After one hour of completion of the scrutiny of all nomination papers on **3<sup>rd</sup> September 2024** the Returning Officer shall prepare a list of validly nominated candidates in **Form 4** and same shall be placed on the website of NRAI and in NRAI Office. The Contesting Candidates can take a copy from the Returning Officer.

#### **8. Withdrawal of candidatures:**

- (1) Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his/her candidature, on **4<sup>th</sup> and 5<sup>th</sup> September 2024** between **11.00 am to 1.00 pm** on each day.
- (2) Notice of withdrawal of candidature shall be submitted in **Form 5**, either by the candidate himself/herself or by a person duly authorized by him/her in writing.
- (3) Notice of withdrawal of candidature shall be final and shall not be allowed to be withdrawn.
- (4) The Returning Officer shall accept the notice of withdrawal if he is satisfied as to the genuineness of the notice.
- (5) As soon as after **11.00 AM on 6<sup>th</sup> September 2024**, the Returning Officer shall prepare the final list of contesting candidates in **Form 6**, display a copy of the said list in conspicuous place in NRAI Office and on NRAI's Website, and furnish a copy of the same to each of the candidates, his / her authorized representative, if so demanded.
- (6) The names of the contesting candidates in **Form 6** shall be arranged, in alphabetical order according to English alphabets.

#### **9. Uncontested Returns; and Contested Elections**

- (1) In case of only one nomination for the post of President NRAI, in **Form 6**, the contesting candidate shall be deemed to be duly elected unopposed, and it shall not be necessary to take a poll for election to the post.
- (2) Where the number of contesting candidates, for the post of President, in **Form 6** is more than one, a poll shall be taken by secret ballot for filling this post.
- (3) The ballot papers for this post shall be in **Form 7**.
- (4) The names of contesting candidates on the ballot papers shall appear in the same order as in **Form 6**.



**10. Poll:**

- (1) The Poll for the said Post, under clause 2, shall be taken on **21<sup>st</sup> September 2024** during the General Body Meeting at Constitution Club, New Delhi. The Notice for General Body Meeting shall be issued by the Secretary General of NRAI, as per Clause 25 of Rules and Regulations of NRAI.

The Returning Officer, Election Staff, Observer (if any), and members listed in Form 1, as per Clause 4 (1) shall be admitted, upon the presentation of a valid photo ID card at the venue described above of the General Body of the NRAI. No other person will be present or attend the meeting without the approval of the RO of the General Body to be held on **21<sup>st</sup> September 2024**.

- (2) Each contesting candidate can nominate one person, (If he / she so desires), only amongst the Authorized Representatives (from Form 1) to be present at the Poll (Polling station).
- (3) At the poll, each Member of the General Body of NRAI, whose name is included in the Electoral College list in **Form 1**, shall be entitled to cast one vote for the post of President NRAI.
- (4) In case any voter casts his/her vote for more than one candidate, his/her vote shall be invalid.
- (5) Each voter shall be required, before he/she is supplied with a Ballot paper, to give his/her signature on the authenticated copy of the Electoral College list in **Form 1** used by the Returning Officer for taking the poll.
- (6) The Voter shall record his/her vote on the ballot paper in secrecy in a voting compartment specially provided for the purpose at the polling station.
- (7) The voter shall record his/her vote on the ballot paper by placing a tick mark (✓) against the name of the candidate of his/her choice, and any other mark, like (x) etc. or word, placed on the ballot paper by him/her shall render the ballot paper liable to rejection.
- (8) The Tick mark (✓) to indicate the vote shall be placed by the voter only by means of article specifically provided for the purpose by the Returning Officer, and a ballot paper marked otherwise by means of any pen, ball point pen, etc. by the voter shall render the ballot paper liable to rejection.
- (9) The ballot paper marked by a voter shall be deposited by him/her in a ballot box specially prepared and sealed by the Returning Officer and placed at such a conspicuous place in the polling station that it shall be constantly visible to all present in the polling station.
- (10) The voting shall be held on **21<sup>st</sup> September 2024 between 11.15 am to 1.30 pm**. The Returning Officer shall close the poll at the appointed hour; however, all those voters who



are present at the polling station at the appointed closing hour shall be entitled to vote even if the poll proceedings have to be continued for some more time.

- (11) After all the voters referred to in sub-clause 10(3) have voted, the Returning Officer shall close the ballot box and shall not permit thereafter any person to vote.

#### 11. **Counting of Votes:**


- (1) The Returning Officer shall take up the counting of votes, as soon as may be after the polling for any post is complete.
- (2) Each contesting candidate can nominate one authorized representative (as clarified in S. No. 10 (2)) and he/she shall be entitled to be present at the place of counting of votes.
- (3) Each ballot paper on which a vote has been recorded in accordance with sub-clauses (3) to (8) of clause (10) shall be treated as one vote for the-candidate for whom it has been validly marked; and if any ballot paper has been marked in violation of any of the aforesaid provisions of sub-clauses (3) to (8) of clause (10) shall be rejected by the Returning Officer.
- (4) The votes validly cast for each of the contesting candidates shall be counted and recorded for each candidate in **Form 8**.
- (5) The Returning Officer shall thereafter announce the result of counting and, the candidate who has secured the maximum number of votes in the said descending order, shall declare him / her to have been duly elected to the post of President NRAI.
- (6) In case two or more candidates secure equal number of votes, the winner shall be declared by the Returning officer by toss.

#### 12. **Declaration of Results:**

The name of contesting candidate, who has been elected at the election shall be so declared to be the President, NRAI by the Returning Officer at the General Body Meeting in the **Form 9**.
