SUB: Selection Trial 1 & 2 for Rifle/Pistol events at Dr. Karni Singh Shooting Ranges, New Delhi for Senior Men and Women from 6<sup>th</sup> to 18<sup>th</sup> January 2021.

Dear Sir/Madam,

It has been decided to hold selection trial no. 1 & 2 in Olympic Events at Dr. Karni Singh Shooting Ranges, New Delhi as per the program attached as per Annexure "A".

Scores will be entered in main log sheet for calculating the average and will be valid for selection in subsequent international competition.

These trials will be organized and conducted by the NRAI. On the recommendations of the Technical Committee, the shooters as per list attached – Annexure "C" are only permitted to participate in these trials. The trials will be conducted in Olympic Events.

There will be a total of four selection trials in January and February 2021. The FAS as on 18<sup>th</sup> March 2020 would be the base score. The ranking lists are available on our website <a href="https://www.thenrai.in">www.thenrai.in</a>. The selection of teams will be done as per the Selection Policy 2019-20, which has now been extended till the time 64 NSCC is conducted. The selection of teams will be for Delhi and Korea World Cups.

For Rapid Fire Pistol Mix event, NRAI will conduct four trials in Rapid Fire Pistol event for women. Shooters, who have been selected to participate in Sports Pistol event, would only be allowed to participate in these selection trials. No Finals will be conducted. Three Olympic bound probable in Sport Pistol event have not been selected to participate in Rapid Fire Pistol women event.

The selection of Mix Team events, including Rapid Fire Pistol Mix Team events and 50M Rifle 3P Mix Team event will be done in accordance with the decision of the Governing Body, as applicable for selection of Mix Team events.

Rajiv Gandhi Khel Ratna Awardee / Arjuna Awardee will be allowed to participate in these trials irrespective of their ranking.

The terms and conditions for selection trials are as under:

- i. Due to COVID 19 conditions, shooters are requested to strictly follow SOPs as laid down by Govt. of India/NRAI/. Copy of SOPs laid down by NRAI is attached herewith for your ready reference as per Annexure "D".
- ii. All shooters/coaches must undergo a Covid test prior to entering the range for first trial and submit a negative report from a Govt. certified lab to NRAI. This report should not be older than 48 hours from the date of first trial.

- iii. The tentative program is attached herewith. There will be only one detail for each event. No request for any adjustment shall be entertained. The time and details are attached herewith and shooters are required to enter the range 90 minutes before the reporting time at range so that they can report on time for their detail.
- iv. Only one person will be allowed to accompany the shooter subject to production of valid negative COVID 19 report.
- v. Shooters will have to make their own arrangements for arms and boarding & lodging. Ammunition will be provided at Shooting Ranges against payment and on valid arms license.
- vi. The entries will only be accepted through "NRAI's ONLINE SYTEM". No paper entry will be accepted. Shooters are required to visit our website <a href="www.thenrai.org">www.thenrai.org</a> to file their online entries. The online entries with normal fee will be accepted <a href="till 9.30">till 9.30</a> <a href="PM on 28th">PM on 28th</a> <a href="December 2020.</a> Late entries with triple entry fee will be accepted till 9.30</a> <a href="PM on 2nd January 2021">PM on 2nd January 2021</a>.
- vii. Details of entry fee are attached at annexure "B".
- viii. In case any shooter/affiliated unit need any assistance for filing the entry, he/she must approach NRAI immediately BUT during working hours <u>before 5.30 PM on 28<sup>th</sup> December 2020</u> so that their entries are accepted with normal fee. Shooters contacting for assistance after 1<sup>st</sup> January 2021 are liable to pay triple fee. Shooters may contact Mr. Anjan Singh in NRAI office on phone numbers 011-8448770867. Shooters may also send email on email ID indiashooting@gmail.com
  - ix. The Entry fee paid by the shooters for Selection Trials, which were scheduled to be held in April 2020, will be refunded to shooters. Shooters are requested to send their bank details so that amount is refunded to them. No fee adjustment of fee can be made.
  - x. Shooters are required to print their competitor cards and Equipment Control Form and bring the same with them at the time of participation, failing which Rs. 200/- will be collected for each card/form, if supplied by NRAI. Shooters can print their cards/forms after 2<sup>nd</sup> January 2021.
  - xi. Scores of these selection trials will be considered for selection of teams for international competitions and national ranking.
- xii. The Finals will also be conducted as per ISSF Rules in all Olympic events.
