# SUB: Selection Trial Rifle/Pistol events at Dr. Karni Singh Shooting Ranges, New Delhi for Seniors/Juniors/Youth from 1<sup>st</sup> to 12<sup>th</sup> August 2021.

Dear Sir/Madam,

It has been decided to hold two selection trials at Dr. Karni Singh Shooting Ranges, New Delhi as per the program attached at Annexure "A" for the following international competitions:

14<sup>th</sup> Asian Airgun Championship, Kazakhstan for Seniors/Juniors/Youth ISSF Junior World Championship, Lima, Peru.

Shooters as per list attached at Annexure "B" are permitted to participate in those events under which they are under the 18<sup>th</sup> rank during 63 NSCC. The junior/youth shooters, who fulfil the ISSF age criteria have been selected for selection trials. Shooters having an identical score of 18th rank, are also invited for selection trials. Shooters who are now above the age of 21 years have been excluded and next rank shooters, fulfilling the age criteria have been included in the list.

#### a. TRIALS FOR MIX RAPID FIRE PISTOL EVENTS:

For Rapid Fire Pistol Mix event, trials will be conducted in Rapid Fire Pistol event for women. Women shooters, who have been selected to participate in Sports Pistol event, would be allowed to participate in these selection trials. No Finals will be conducted.

#### **b. PARTICIPATION/SELECTION IN OPEN EVENTS:**

The trials will be conducted in following open events, which are part of ISSF Junior World Championship, Peruand both men and women can participate in these events:

25M Standard Pistol 50M Pistol 50M Rifle Prone

**Standard Pistol** – Women shooters, who are eligible to participate in Selection Trials in 25M Pistol events, will be allowed to participate in Standard Pistol selection trials.

**Free Pistol** – Women shooters, who are eligible to participate in Selection Trials in 10M Pistol/25M Pistol events, are allowed to participate in Free Pistol selection trials.

**50M Rifle Prone** – Since NRAI conducts separate matches in Prone event, 18 shooters from each category of Men and Women are invited for selection trials.

The combined trials (no separate details for men and women) will be conducted in the above events and one ranking list, based on scores achieved by the shooters (both by men and women) will be prepared and shooters will be selected accordingly. There will not be a separate ranking list for men and women.

Rajiv Gandhi Khel Ratna Awardee / Arjuna Awardee will be allowed to participate in these trials irrespective of their ranking for selection in senior events of Asian Airgun Championship.

### c. SELECTION CRITERIA FOR SELECTION OF TEAMS

The number of shooters for participation in juniors and youth events in above international competitions will be as per norms of the organizers and ISSF rule 7.5.3 and subject to the approval at Govt. Cost by Sports Authority of India.

The NRAI shall select shooters on the basis of policy of "Best Foot Forward".

i. Shooters participating in Tokyo Olympic Games are exempted from participation in these selection trials and they will be considered for selection as per clause (ii) and (v) below.

ii. Selection in senior events will be done on the basis of senior selection policy - 4/5 last scores, which will include scores of four trials in 2021, Delhi WC, European Championship, Osijek WC and Tokyo Olympic Games. This is applicable to the selection of shooters for Asian Airgun Championship, Kazakhstan.

iii.For juniors and youth, average of two high out of three scores (63 NSCC and two trial scores in August 2021) will be the basis of selection of shooters.

iv. In case of any junior/youth shooter, who is in the list of shooters for seniors and is being considered for selection for a junior event, his/her selection will be done on the basis criteria as stated under (ii) above.

v. The shooters, below the age of 21 years, who are participating in Tokyo Olympic Games shall be selected on the basis of their performance as stated under clause (c) (ii) above in senior or junior category, as decided by the Selection Committee.

vi. Selection in open events will be done on the basis of average of two selection trials being conducted in August 2021.

vii. The selection of all Mix Team events will be done in accordance with the decision of the Governing Body, as applicable for selection of Mix Team events.

viii. The scores of these trials may also be considered for future international competitions, as decided by NRAI.

ix. Notwithstanding, in extraordinary circumstances, with justification in writing, the Selection Committee would have the authority to deviate from above norms and under all circumstances, the decision of the Selection Committee /NRAI would be final and binding on all.

## d. THE OTHER TERMS AND CONDITIONS FOR SELECTION TRIALS ARE AS UNDER:

- i. Due to COVID 19 conditions, shooters are requested to strictly follow SOPs as laid down by Govt. of India/NRAI/Delhi Govt.
- ii. All shooters/coaches must undergo a Covid test prior to entering the range for first trial and submit a negative report from a Govt. certified lab to NRAI. This report should not be older than 48 hours from the date of first trial. VIOLATION OF COVID PROTOCOLS MAY LEAD FROM DISQUALIFICATION FROM SELECTION TRIALS.
- iii. The tentative program is attached herewith. The time and date for details would be notified on the website of NRAI <u>www.thenrai.org</u> Shooters are required to enter the range 90 minutes before the reporting time at range so that they can report on time for their detail.
- iv. Only one person will be allowed to accompany the shooter subject to production of valid negative COVID 19 reports.
- v. Shooters will have to make their own arrangements for arms and boarding & lodging. Ammunition will be provided at Shooting Ranges against payment and on valid arms license.
- vi. The entries will only be accepted through "NRAI's ONLINE SYTEM". No paper entry will be accepted. Shooters are required to visit our website <u>www.thenrai.org</u> to file their online entries. The online entries with normal fee will be accepted <u>till 9.30</u>
  <u>PM on 21<sup>st</sup> July 2021.</u>Late entries with triple entry fee will be accepted till 9.30
  <u>PM on 23<sup>rd</sup> July 2021.</u>
- vii. Details of entry fee are attached at annexure "C".
- viii. In case any shooter/affiliated unit need any assistance for filing the entry, he/she must approach NRAI immediately BUT during working hours <u>before 5.30 PM on 21<sup>st</sup> July</u> <u>2021</u>so that their entries are accepted with normal fee. Shooters contacting for assistance after 21<sup>st</sup> July 2021 are liable to pay triple fee. Shooters may contact Mr. Anjan Singh in NRAI office on phone numbers 011-8700094163. - ix. Shooters are required to print their competitor cards and Equipment Control Form and bring the same with them at the time of participation, failing which Rs. 200/- will be collected for each card/form, if supplied by NRAI. Shooters can print their cards/forms after 23<sup>rd</sup> July 2021.
- x. The Finals will also be conducted as per ISSF Rules in all Olympic events.
